# Community Small Grants Round 2 now Open

## Applications close 31 March 2021

In recognition of the pivotal role that community groups and organisations play in developing vibrant and diverse communities, Council is committed to providing support and assistance through the Shire of Three Springs Community Small Grant Program.

The program's objectives are to provide funds of up to \$3,000 to community-based organisations to support social, economic, recreational, art, and cultural benefits. The focus is on assisting groups in delivering the following:

1. Supporting volunteers by building the capacity of local clubs and organisations with small equipment purchases;
2. Support programs, activities and initiatives delivered by community groups;
3. Support community development initiatives;
4. Increasing the range of events, activities, and services within the Shire;
5. Providing mentoring opportunities to community organisations to strengthen their organisation; and
6. Generating local economic activity, tourism and development.

There are three categories available through the Community Small Grant Program. Before commencing an application, please read the Guidelines.

### **Community Small Grants**

**Up to \$3,000 - two rounds per annum**

This funding assists with funding towards infrastructure and equipment and sponsorship requests in excess of \$250.00. Examples of this type of funding may include events, uniforms or equipment.

### **Waiving of Fees**

**Open round - up to \$1,500**

Council's Waiving of Fees stream assists with funding programs with a reduction or waiving of Council's fees and charges, including but not limited to community bus use, facility hire, and photocopying. Examples of this type of funding may include Senior Day trips, facility hire for school holiday programs.

### **Sponsorship**

**Open round - up to \$250**

Council's sponsorship program is to assist with funding towards running events and projects. Examples may include significant events, community workshops, information sessions and school holiday programs and activities.

A committee assesses the applications.

### It's not easy being green

Labels such as 'eco-friendly' and 'sustainable' can be attractive for shoppers wanting to do their bit for the environment, but it's not always easy to sort what's fact from fiction.

That's why a recent internet sweep by consumer agencies throughout the world, including Consumer Protection in WA, focused on identifying misleading environmental claims for the first time.

Globally, 1,095 websites promoting products and services like clothes, cosmetics and food were analysed in the International Consumer Protection Enforcement Network (ICPEN) sweep, with 40 per cent found to be making claims or using brand-names or language that weren't supported by evidence.

Of the 74 Australian retail websites targeted, concerns were raised about one-third of them for a number of reasons. Some traders used terms like 'eco' or 'sustainable' in reference to 'natural products', but failed to provide adequate explanation or evidence. Others used their own brand eco logos and labels not associated with an accredited organisation, while a number even hid or omitted certain information, such as a product's pollution levels.

At this stage, regulators haven't decided whether consumer protection laws have been broken, but the traders identified will now come under greater scrutiny and action taken if evidence of misleading consumers is found.

We hope the results of this survey will encourage consumers to look past the logo, slogans and packaging, and read the ingredients label. They should ask traders to provide evidence of their green practices and claims, such as independent assessments of the eco-friendly nature or ingredients, as well as proof of any accreditations, affiliations or endorsements from environmental organisations.

### Don't complain, lodge a complaint

If you have a bad experience with a business, sharing your story on social media and elsewhere online might seem like a good way to warn others to steer clear, but it may not be the most effective way to have your voice heard.

Consumer laws in WA give us the authority to receive and investigate complaints against traders, before taking the appropriate action – such as an attempt at conciliation, a public naming or even potentially a prosecution in court.

It's important to remember that defamation laws extend online, meaning that anyone using social media should be careful about what they post. A split-second decision to write or share information online could become a costly move if legal action is pursued by the aggrieved party.

Our work relies on the WA community communicating with us so we can ensure traders are doing the right thing. During a recent investigation of one business, it was discovered more than 100 consumers had complained on a social media group, however only a relatively small number of complaints had been lodged with Consumer Protection.

By lodging a complaint you can help us to better target non-compliant traders through trader engagement and proactive campaigns to prevent ongoing non-compliance. If you have been unable to resolve an issue with a trader, lodging a formal complaint will allow us to attempt to conciliate the matter for you.

This means we will talk to the trader on your behalf to find an outcome that is acceptable to all parties. This is a free service and conciliation is often the most efficient and effective way to handle complaints.

Should a mutual agreement not be possible, then other options may be presented, such as recommending an application be made to the Magistrate's Court, the State Administrative Tribunal, or seeking independent legal advice. Enforcement action may be considered by Consumer Protection where non-compliance is identified.

## A Win for Durack Education

3 March 2021

The opening of the rebuilt Moora Residential College today is a significant event for all families and educators in Durack. I congratulate everyone that has contributed to this great result.

Federal Member for Durack, the Honourable Melissa Price, said it was the Morrison Government who fought to stop the McGowan Government's negligence when it announced in 2017 it was going to close this important facility, basically putting it in the 'too hard' basket by a city centric government.

"Without the sustained community campaign that was mounted to fight this decision by the McGowan Government, with little recognition of the importance of this facility, this education option for Durack families would have been lost. I fought very hard to secure the Federal funding to save the residential college. But all credit goes to the powerful campaign of the Moora locals and the thousands of Western Australians who understood what was at stake", Ms Price said.

"It was an expedient decision that made me angry at the time, and one that I and many others knew we had to fight. Today we celebrate a wonderful community victory for country education and common sense. This is a \$8.7 million dollar Morrison Government vote of confidence in regional families", she said.

The project was funded under the Community Development Grants Programme and included the demolition of ageing student dormitories, and the construction of new recreational and accommodation facilities for 50 students who attend Central Midlands Senior High School, adjacent to Moora Residential College.

This project is expected to increase the number of enrolments at the college and therefore increase the number of families remaining in the region and attract new families to the region to live. This results in future socio-economic benefits for the area.

"Local business was also able to demonstrate clearly at the time that a loss of a boarding facility like this in the community would also impact on the boost local business relied on from parents of students at the college shopping and accessing services while in town", Ms Price said.

The completion of this project demonstrates the Morrison Government's commitment to supporting rural and regional students to have access to secondary education, ensuring they have the same opportunities as metropolitan students.

# Police News

A week or two ago we received a phone call from a concerned Three Springs resident. In their travels they had come across a male person they didn't recognise as a local walking West along Eneabba Three Springs Road. The male person was approximately 10 kms out of the Three Springs townsite, looked distressed and out of place. The local spoke with the male who explained he was walking to Eneabba. He only had a small bottle of water with him, but he said didn't need any help. With about 50 kms to go to Eneabba and a 40 degree day, the local knew better and called Three Springs Police.

Three Springs Police attended armed with a few bottles of water and a first aid kit. As it turned out the male person was identified as a Geraldton resident who was wanted for questioning in relation to a number of offences including; steal a motor vehicle, stealing and a fail to stop incident. The fail to stop incident occurred on Midlands Road where the driver at the time, drove so dangerously, with the risk to the community so great, police had to abort their pursuit.

The male was not well and his medical condition took priority over the criminal investigation and as such he was conveyed to Three Springs Hospital. The attending nursing staff were again fantastic and once recovered, the male was released to the custody of Three Springs Police.

Further inquiries identified the same stolen motor vehicle in question had been recovered earlier that morning in Moora. It had been abandoned after a serious single vehicle traffic crash on Midlands Road. Witnesses described a male person matching his description as being seen at the location and walking towards Three Springs.

The male person participated in an electronic record of interview and was later processed and charged. He was due to appear in the Geraldton Magistrates Court on the 4th of March 2021 on charges of charges of Steal Motor Vehicle, Stealing, Driver Failed to Comply with a Direction to Stop and No Drivers Licence. He failed to appear on that date and is now subject of an outstanding Arrest Warrant.

A female suspect has also been identified and is wanted for questioning by police in relation to the same offences. She is also a Geraldton local and is known to frequent Moora.

It was great response and quick thinking by the Three Springs resident that potentially saved the life of the now charged male and allowed Three Springs Police to resolve, apprehend and process a serious offender.

Please remember if you see something that you don't feel is right contact Three Springs Police. If we are out and about and your call gets diverted to Geraldton Police Station please stay on the line and share your information.

## FUN FACT

### The Constellation of Leo the Lion

The constellation Leo is one of the zodiac constellations and one of the biggest in the sky. It represents the Lion and Greek mythology tells the story of Leo being the Nemean Lion, which terrorized the citizens and had a hide that could not be punctured by iron, bronze or stone.

Zodiac constellations lie along the plane of the ecliptic or path of the Sun, so the Sun appears to pass through these constellations throughout the year.

The brightest and 'Leading' star in Leo is Regulus, Alpha Leonis. Two other bright stars in the constellation are Al Geiba, meaning "the lion's mane," and Denebola, which means "tail of the lion."

Leo is associated with two meteor showers. The Leonids is a popular shower with high meteor rates and peaks mid-November and a minor shower that peaks in early January. Meteor showers usually take the name of the constellation they appear to radiate out from.

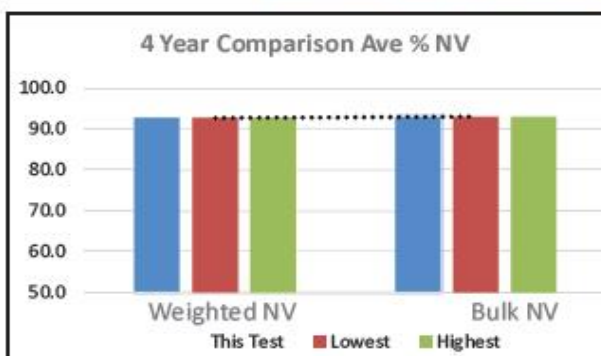
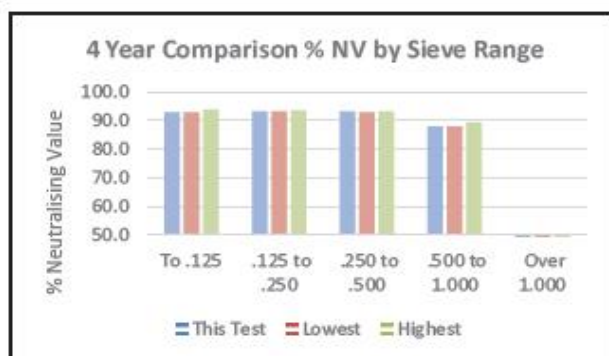
