Where the area of the land is 3,000m² or more, a firebreak must be provided not less than 3 metres in width inside and along the whole of the external boundaries of the properties owned or occupied and all flammable material must be cleared a distance of 2.7m from all buildings and/or haystacks situated on the land and maintained free of such material until the 15th March.

# FUEL STORAGE AREAS

On or before the 1st October all grass and similar material is to be cleared from such places where drum ramps are located and where drums, empty or full, are stored and such areas to be maintained cleared of grass and similar flammable material until 15th March

# FARM BUILDINGS AND UNATTENDED ELECTRIC MOTORS AND HAY STACKS

Fire breaks at least 3 metres in width completely surrounding and not more than 20 metres from the perimeter of any building, group of buildings or haystacks, All flammable material must be removed from an area 2.7 metres in width immediately surrounding the building. All flammable material must be removed from an area 3 metres in width immediately surrounding an unattended electric motor site.

# UNATTENDED FUEL OPERATED MOTORS

All flammable material must be removed from an area 3 metres in width immediately surrounding an unattended fuel operated motor whether the motor is intended to be used or not.

## RURAL LAND

Firebreaks must be provided not less than 3 meters in width inside and along the whole of the external boundaries of the properties owned or occupied: where this is not practicable the firebreaks must be provided as near as possible to, and within, such boundaries

# BARBEQUES AND INCINERATORS

Gas and electric barbeques are permitted any time. Solid fuel barbeques and incinerators are PROHIBITED on days of VERY HIGH FIRE DANGER or above.

### PENALTY

The penalty for falling to comply with this notice is a fine of up to \$400 and a person in default is also liable, whether prosecuted or not, to pay the cost of performing the work in this notice, if it is not carried out by the owner or Occupier by the date required by this notice

#### Transitioning to normal tenancy laws

As the curtains close on Western Australia's COVID-19 emergency period, we begin transitioning back to normal tenancy laws in which there is no longer a moratorium on rent increases and some evictions.

While everyone adjusts to the changes, Consumer Protection has been fielding enquiries from landlords and tenants wondering about their rights and responsibilities when it comes to ending a tenancy, rent rises and rental arrears.

When increasing rent, landlords need to provide tenants at least 60 days' notice via a 'rent increase notice – form 10'. While there is no cap on rent increases, a tenant can apply to the Magistrate's Court for a determination if they believe the amount is excessive.

Tenants should know they cannot be evicted from a property straight after the end of the emergency period, as there is a process involved in ending a tenancy. Landlords are required to give 30 days' notice to end a fixed-term tenancy and 60 days' notice to conclude a periodic lease.

If a tenant has received a notice of termination, but has not left the premises on the due date, the landlord must then apply to the court for an order for vacant possession of the property.

Should a tenant need emergency relief assistance, financial counselling or other community help, agencies such as the Salvation Army, Sun City Christian Centre and Regional Alliance West may be able to provide support and guidance. Consumer Protection has an online guide to help tenants find a service that may be able to help.

Consumer Protection will continue playing its part to preserve tenancies across WA through the Residential Rental Relief Grants Scheme and providing a conciliation service to help tenants and landlords reach agreements on issues that have arisen during the pandemic.

Applications for conciliation, rent arrears assistance and future rent support grants will remain open until 28 June 2021, but in the meantime we urge landlords and tenants to act and negotiate in good faith to agree on reasonable and workable tenancy agreements, helping to create stability and certainty moving forward.

#### Beware vaccine scams

Australia's vaccine roll-out will hopefully spell the beginning of the end of the coronavirus crisis, but we can't afford to become complacent when it comes to avoiding COVID-19 related scams.

Scams where COVID-19 was mentioned have so far stolen \$8.4 million from Australians since the start of the pandemic, while 20 victims in Western Australia have reported losing almost \$144,000 to WA ScamNet.

There are concerns those figures could rise further now that vaccines are being rolled out across the country, following a similar trend seen in other countries like the United Kingdom.

Some of the scams seen so far involve payment requests for early access to vaccines, offers to mail vaccines, investment opportunities in the Pfizer vaccine, as well as fake surveys that offer prizes or early vaccination access.

In an effort to counteract scams and the spread of misinformation, the ACCC's Scamwatch service has published <u>new information</u> about how vaccines will be distributed, how the Government will communicate with Australians about the roll-out and tips to avoid being scammed.

It's important to know that COVID-19 vaccines will be free for everyone living in Australia, so no amount of money will be able to buy you a spot on an 'early-access' list, nor will you require a doctor's prescription to receive one. If you receive an email or text message telling you otherwise, it's likely to be a scam.

Scammers may pretend to have a connection with you, so it's important to stop and check, even when you are approached by what you think is a trusted organisation.

WA ScamNet warns against providing your personal, banking or superannuation details to strangers who have approached you, and to avoid clicking on links in unexpected emails or text messages. Instead, go directly to the website through your browser. Eg. to reach the MyGov website type 'my.gov.au' into your browser yourself.

### Phase 1B COVID-19 vaccine rollout begins in Durack next week. 18 March 2021

Phase 1B of the rollout will begin across Durack next week, with a focus on the elderly, indigenous people, those with underlying medical conditions and more healthcare workers.

Federal Member for Durack, the Honourable Melissa Price, said services will begin from next Monday, March 22.

"Phase 1B of the rollout will see 6 facilities initially available in Durack including the Broome Respiratory Clinic, Broome Regional Aboriginal Medical Service and in Kununurra at the

Ord Valley Aboriginal Health Service, and Wunan Health and Geraldton's Respiratory Clinic", she confirmed.

"Nationally over 100 Aboriginal Health Services and 130 Commonwealth operated GP-led Respiratory Clinics, who have been instrumental partners in the COVID-19 response to date will be progressively added as additional vaccine providers," Ms Price said.

Those eligible for Phase 1B will be able to find a vaccination provider through the new national vaccination information and location service, at the <u>Department of Health website</u>.

This will enable people to locate their nearest general practice providing General Practice Respiratory Clinic vaccinations and link through to their online booking system or phone number to make the appointment.

Appointments on the service finder will increase as general practices establish their systems and vaccine supply. More appointments will become available as more clinics come on-board.

People will still be able to book their vaccine appointments directly at a participating general practice – as they do now, for instance, to get a seasonal flu vaccine.

As the rollout moves into Phase two, additional general practices and selected community pharmacists will also participate in the program. No-one will miss out, whether they live in a city or country town or a very remote area.

I'm pleased to announce there hasn't been any offences recorded in the Three Springs Sub District during the reporting period. This is something that we would all like to maintain and continue. This can be achieved by removing valuables from sight, securing your property and reporting suspicious behaviour.

Unfortunately, earlier this year we had a small number of people engage in anti-social behaviour. All those people were identified and have since been charged. Some have been dealt with already and others will be attending Three Springs Magistrates Court at its next sitting on the 28<sup>th</sup> of April. If you do engage in anti-social behaviour, you can be issued a \$500 infringement or if deemed even more serious a summons to court where the penalty is determined by a Magistrate and will also have additional court costs.

Recently Three Springs Police have been made aware of several residents receiving telephone calls from fraudsters attempting to con them out of their hard-earned savings. These networks are usually internationally based and have become increasingly sophisticated. This makes the identification and apprehension of these offenders almost impossible, so the best we can do is educate people to minimise their harm. What they want is access to your online banking accounts. They can only achieve this by obtaining personal details, account numbers and passwords. It is very important that you never provide these details over the phone. If you have any doubts to the validity of a phone call simply ask them to provide their name and contact details and you will call them back. This will give you an opportunity to validate the phone call and if they are legitimate, they will have no issue with this. If they are fraudsters, they will come up with every excuse under the sun for this not to happen. Remember it is important to trust your instincts, if it doesn't feel or sound right it is likely that it is a scam.

Some of you will be lucky enough to be heading out of town over the school holidays. For those who would us to keep an eye on their house during their absence feel free to drop into the police station and let us know. The period also coincides with huge increases in people on the roads and passing through our town. This also means double demerit traffic actions by WA Police. Three Springs Police and our Policing partners will be out on the roads ensuring everyone is complying with the road rules. Double Demerit points apply to speeding, drink driving and mobile phone use whilst driving offences. Please be patient and fully observant of road, weather and other driving conditions.

## First-class Seasonal Updates delivers local research and laughs

More than 65 growers and industry gathered at Dandaragan Community Centre for the West Midlands Group's (WMG) Seasonal Updates on Tuesday, 16 March.

The knowledge sharing and networking event featured speakers from across the ag sector presenting on topics from transitioning to a non-mulesing operation to the 2020 season National Variety trial results and the top crops to look out for in the coming years.

CBH Group CEO, Jimmy Wilson delivered an update and answered grower questions about how the cooperative plans to navigate global market uncertainty in 2021, saying they will continue to "invest in the network, efficient and grower focused services, and provide low-cost inputs for WA growers, and develop of markets for WA grain in Asia".

Department of Primary Industries and Regional Development research scientist, Chad Reynolds unpacked the results from a trial conducted at Lawson Grains operation "Yanda", just south-west of Moora, which Investigated the best combination of clay application rate, method of Incorporation and repeated strategic deep tillage approach to optimise long-term crop production benefits.

"For this repellent deep sand spading has proven, over five seasons, to be the most effective and profitable amelioration method," he said.

"Repeat spading had significant yield benefit but longer-term assessment is needed to determine if the additional cost is warranted," Mr Reynolds said.

The WMG's mixed farming systems officer, Brianna Hindle shared results from last year's Dandaragan and Coorow trials investigating late season amelioration and pasture varieties.

"Mixing pasture varieties increased dry matter production, feed nutrition value and soil coverage at the Coorow trial site,"

"At both the Dandaragan and Coorow sites, ameliorating following the season break decreased the risk of erosion from major weather events," Ms Hindle said.

Ms Hindle encouraged growers to consider the purpose of any pasture sown to determine whether an early winter feed or a spring feed source is required.

Trial host growers Duncan Glasfurd (Dandaragan) and Charles Wass (Coorow) were on hand to answer questions regarding their take away messages from the trials, and if the results had an impact on their decisions for 2021 paddock planning.

Australian cricketing legend, Brad Hogg was a fantastic final speaker for the day. Originally from Williams, Mr Hogg shared hilarious anecdotes and inspiring takes on his career kept the crowd on their toes despite the long day.

#### Wild dog, feral pig numbers down after coordinated control in Midlands region

The Midlands Biosecurity Group has been busy implementing their pest programs over the last few months with reports indicating that these efforts are now impacting wild dog and feral pig numbers.

According to MBG Coordinator Chris O'Callaghan recent reports have indicated that wild dogs are beginning to move as the mating season commences and young dogs are seeking new territory and mates.

"It is pleasing to hear that in many hot-spot areas of the Midlands through continued control efforts many of the indicators of dogs have declined,"

"However, reports of wild dog sightings are still coming in from other areas and diligence is encouraged," said Chris.

"Experience from other areas suggests that we need to drive fox numbers down before any meaningful impact can be made on wild dogs. The reason being is that foxes take all the baiting product and set off traps. Farmers need to be baiting regularly to drive numbers down, if you can see fox tracks, then there's not enough bait going out."

Chris also suggested sheep farmers keep a good eye on their flocks and report any unusual behaviour, especially heading into lambing in the coming months.

MBG Licensed Pest Management Technician, Paul Pitaro said feral pig baiting had been conducted in many locations throughout the region and had so far yielded good results despite recent rains.

"Initially the earlier rain in the north-east played a bit of havoc with pig movement and feeding as they took to wallowing in small pools of water left in clay pans or on the side of the roadways, and watering at troughs slowed while clean water would have been left in some rock pools.

"After a couple days of hot dry weather, it dried up nicely and feeding became a bit more steady, however some mobs still did not return to the usual locations, whilst others seem to keep close and feed regularly,"

Paul also recommended that free-feeding with good quality clean grain is the key to a successful baiting program.

Mr O'Callaghan said the MBG continues to supply baiting products on request provided the landholder has a restricted chemical permit in place.

"The meat baits are being reported to be very effective and the group is receiving very good feedback regarding their quality,"

The MBG has contracted an additional LPMT, Andrew Walker, for the month of March to get an extra set of hands on the ground in this crucial time of year for pest control.

Andy will be working with farmers across the Moora, Badgingarra, Warradarge and Coorow areas to ensure farmers have their Restricted Chemical Permit paperwork in place and any pest control is well-targeted.




