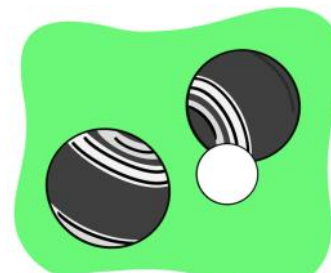

### How to handle a consumer complaint yourself

When a service you've received isn't up to scratch, or a product you've bought doesn't work as it should, you may wish to seek a remedy from the business that supplied it.

Before contacting Consumer Protection for help, it is always important to try to resolve the matter yourself.

This is because in most cases an issue with a business or trader can be resolved pretty quickly just by explaining the situation and offering a mutually acceptable solution.

You should start by talking it over with the appropriate person in the organisation, such as the owner, salesperson or a manager. Remember that sometimes the person you're talking to may not be in a position to give you what you want straightaway, so it's important to stay polite and if necessary ask to discuss the matter with the person in charge.

Explain what the problem is and what you want them to do about it, such as a repair, refund or replacement and state when you want it done by.

If the phone call or visit to the business doesn't resolve your issue, then the next step is to follow-up with an email that provides details about the issues and your attempts to resolve it.

Consumer Protection has produced some [sample letters](#) on its website that may assist you, in which you should:

- Quote your reference, agreement or account number if you have one;
- Enclose a copy of any receipt, proof of purchase or any other relevant documents; and

Request a response within a reasonable timeframe (set a deadline).

Failing this, the next step is to find out if there is an organisation responsible for the industry or practice you are having problems with and contact them. Often an industry has its own internal complaint resolution body, which can help to resolve complaints or provide advice to consumers.

### FuelWatch keeps dollars in your bank, not in your tank

With fuel prices recently hitting record-highs, it's a particularly important time for consumers to have the information they need to save money at the bowser.

That's where our free FuelWatch service can help, with a revamped website containing interactive mapping features that makes it quick and easy for WA motorists to compare prices to find the best deal.

The savings can be significant in regional WA, particularly when travelling. Fuel prices do vary between regional areas, as well as within towns, it is worthwhile spending just 30 seconds on the website before you fill-up to find the cheapest fuel in your area and on your travels.

More than 80 per cent of regional service stations are covered by FuelWatch. By law, these service stations are required to notify FuelWatch of their following day's prices by 2pm each day and must lock-in these prices for 24 hours from 6am, meaning WA motorists are free from the frustrating intra-day price fluctuations that those in other Australian States still experience.

In turn, this price transparency and certainty helps to put downward competitive pressure on prices. Motorists should know they can put further pressure on fuel retailers by using the price information to buy from the cheaper retailers.

The FuelWatch team also works behind the scenes to ensure fuel retailers and comply with their legal obligations, and responds to complaints and reports of non-compliance, which can result in fines or even prosecution.

It is important to realise that neither the State nor Federal Governments control fuel prices, which fluctuate for a number of reasons, including changes to international benchmark prices, the value of the Australian dollar to the US dollar, local competition and the daily pricing decisions made by wholesalers and retailers.

International fuel prices have continued to increase recently due to a number of factors, including rising demand following the relaxation of COVID-19 restrictions, as well as supply constraints exacerbated by the Organisation of the Petroleum Exporting Countries and a number of allied oil producing nations such as Russia (known collectively as OPEC+) placing limits on oil production.

## More Assistance for Cyclone Seroja impacted businesses

26 October 2021

Small businesses in Durack directly impacted by Tropical Cyclone Seroja can now access grants of up to \$25,000 to help with clean up and reinstatement costs to resume operations.

The Small Business Recovery Grants are jointly funded by the Commonwealth-State Disaster Recovery Funding Arrangements.

Federal Member for Durack said the grants will provide local small businesses in 16 local government areas with access to a range of practical assistance measures to help get them back to business.

"It's crucial for the recovery of our region that we get small businesses back on their feet. Many local businesses sustained significant damage from Cyclone Seroja. There are costs related to cleaning up, repairing premises, replacing tools and stock — not all of which was covered by insurance," Ms Price said.

"These businesses are at the heart of their communities and need support to meet these costs and get up and running again," she said

The grants can assist with the following eligible costs:

- materials and additional labour costs to undertake clean-up
- carting away and disposing of damaged goods and material
- payment for tradespeople to conduct safety inspections
- essential repairs to premises and internal fittings
- purchase or lease costs for equipment essential for the immediate resumption of operations
- leasing of temporary premises, and
- replacement of stock which is essential for the immediate resumption of operations.

The Small Business Recovery Grants are in addition to the earlier Small Business Cyclone Seroja Grant Scheme managed by the Small Business Development Corporation. Eligible businesses may also apply for the Small Business Recovery Grant. Applications are now open online at [www.smallbusiness.wa.gov.au/seroja](http://www.smallbusiness.wa.gov.au/seroja)

## Heritage Grants for Seroja Repair

28 October

Applications are now open in Durack to help with the clean-up and restoration of heritage assets that were significantly damaged by Tropical Cyclone Seroja.

Federal Member for Durack, the Hon. Melissa Price said the Cultural and Heritage Asset Clean-Up and Restoration Grant Program is part of a package of support for individuals, community members, primary producers, business owners and local governments.

"A reimbursement grant of up to \$20,000 is available to assist with costs to clean-up and repair significant cultural and heritage sites across the cyclone-impacted area," Ms Price said.

"Six months ago, Tropical Cyclone Seroja caused major havoc and devastation across our region and I urge those impacted who think they may be eligible to apply for this grant. This is an opportunity for eligible property owners and operators to defray some of their costs, help subsidise restoration works and conserve the historical significance of our heritage places," Ms Price said.

I encourage owners and operators of heritage and cultural places to check out these grants to help related businesses and tourism in the region.

The \$2 million Cultural and Heritage Asset Clean-Up and Restoration Grant Program is part of a \$104.5 million jointly Commonwealth-state funded package under Disaster Recovery Funding Arrangements (DRFA) to assist with clean-up, repairs and resilience works at heritage buildings and Aboriginal cultural heritage sites.

Eligibility and application details are available at [www.emergency.wa.gov.au/recovery](http://www.emergency.wa.gov.au/recovery).

Works must be completed by June 2023 and claims can be lodged until July 2023.

## Seeding Northern Development in Durack

4 November 2021

There is a new Morrison Government grants program to support Durack businesses in the north that will support expansion, diversification and new jobs in local communities.

Federal Member for Durack, the Hon. Melissa Price said applications for the Morrison Government's new \$111.9 million Northern Australia Development Program (NADP) open today.

"From the banks of the irrigation channels of the Ord to Canberra, I have long championed the development of the north. I am thrilled that this new grant program is targeted to achieve that," Ms Price said.

"The Northern Australia Development Program will offer two simultaneous grant streams, covering up to 50 per cent of the total cost of individual projects. These grants will support businesses to fund new capital expenditure investments like the construction of infrastructure or assets, or to undertake business planning and feasibility studies," she said.

The first stream will target small to medium corporations with business expansion and diversification grants of between \$50,000 and \$2 million. The second stream will offer corporations between \$3 million and \$10 million to establish a new industry or grow an existing industry.

To be eligible businesses must have an Australian business number (ABN) and be either an entity incorporated in Australia and a trading corporation, or an incorporated trustee on behalf of a trust.

## Harvesting Operations

No harvesting operations are permitted on **Christmas Day, Boxing Day and New Years Day**. A separate fire fighting fire appliance is required to be present in any paddock being harvested, churning, raking stubble, straw baling and associated allied activities during restricted and prohibited periods. The fire fighting unit must be in a state of readiness and have a minimum capacity of 400 litres of water, a powered pump and at least 15 metres of hose with a minimum diameter of 19 mm and capable of delivering water through an adjustable nozzle is to be readily available to any paddock being harvested. All vehicles or machinery operating in a paddock during Restricted or Prohibited burning times must have a Fire Extinguisher as defined in the Act. A Fire Extinguisher means a device which comprises— a. a container filled with at least 7.5 litres of water and a pump capable of discharging that water, and which is in a sound and efficient condition.

A Harvesting and Movement Ban and Use of Internal Combustion Engines (except for the watering and movement of stock) will be imposed when the actual weather conditions reach a Fire Danger rating of thirty five (35). All such bans are at the discretion of the Chief Bush Fire Control Officer or a duly appointed person

### PROPERTIES WILL BE INSPECTED TO ENSURE THEY COMPLY WITH COUNCILS REQUIREMENTS

#### 1. TOWNSITES

On or before 1st October all town lots within the town sites of Three Springs and Arrino are required to be treated as follows. Where the area of land is less than 3,000m<sup>2</sup>, the property must be cleared, mowed, slashed to a MAXIMUM height of 7.5 cm of all flammable material.

Where the area of the land is 3,000m<sup>2</sup> or more, a firebreak must be provided not less than 3 metres in width inside and along the whole of the external boundaries of the properties owned or occupied and all flammable material must be cleared a distance of 2.7m from all buildings and/or haystacks situated on the land and maintained free of such material until the 15th March.

#### FUEL STORAGE AREAS

On or before the 1st October all grass and similar material is to be cleared from such places where drum ramps are located and where drums, empty or full, are stored and such areas to be maintained cleared of grass and similar flammable material until 15th March

#### FARM BUILDINGS AND UNATTENDED ELECTRIC MOTORS AND HAY STACKS

Fire breaks at least 3 metres in width completely surrounding and not more than 20 metres from the perimeter of any building, group of buildings or haystacks. All flammable material must be removed from an area 2.7 metres in width immediately surrounding the building. All flammable material must be removed from an area 3 metres in width immediately surrounding an unattended electric motor site

#### UNATTENDED FUEL OPERATED MOTORS

All flammable material must be removed from an area 3 metres in width immediately surrounding an unattended fuel operated motor whether the motor is intended to be used or not.

#### RURAL LAND

Firebreaks must be provided not less than 3 metres in width inside and along the whole of the external boundaries of the properties owned or occupied; where this is not practicable the firebreaks must be provided as near as possible to, and within, such boundaries

#### BARBEQUES AND INCINERATORS

Gas and electric barbeques are permitted any time. Solid fuel barbeques and incinerators are PROHIBITED on days of VERY HIGH FIRE DANGER or above.

#### PENALTY

The penalty for failing to comply with this notice is a fine of up to \$400 and a person in default is also liable, whether prosecuted or not, to pay the cost of performing the work in this notice, if it is not carried out by the owner or Occupier by the date required by this notice

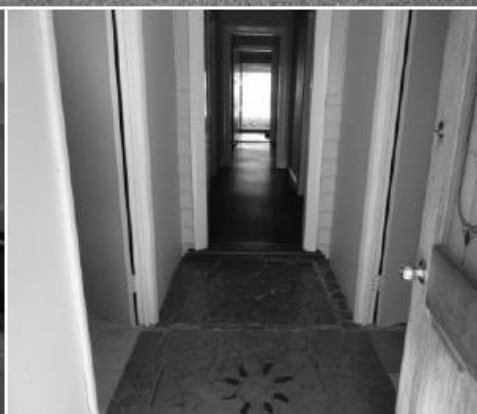
